ENVIRONMENTAL INITIATIVE REMAINED COMMITTED TO PLACING THE HEALTH, SAFETY, AND WELL-BEING OF PEOPLE BEFORE OTHER CONCERNS AND PRIORITIZED THE NEEDS OF THOSE MOST VULNERABLE AND MOST IMPACTED IN OUR DECISIONS. THIS RESULTED IN CLOSING THE MINNEAPOLIS OFFICE AS OF MID-MARCH, REQUIRING STAFF TO WORK REMOTELY FOR THE REMAINDER OF THE YEAR, AND CANCELLING OR SHIFTING IN-PERSON MEETINGS AND EVENTS TO VIRTUAL ONES. A PAYCHECK PROTECTION PROGRAM LOAN WAS ACQUIRED, AND FORGIVEN, FROM THE SBA, WHICH HELPED BRIDGE FINANCIAL SHORTCOMINGS IN THE YEAR, ALLOWING THE ORGANIZATION TO MAINTAIN OUR EMPLOYEES THROUGH THE CRISES. WHILE THESE INCIDENTS MAY HAVE SLOWED SOME OF OUR WORK IN 2020, THEY DID NOT HALT THE PROGRESS IN CREATING A NEW STRATEGIC PLAN AND HELPED REINFORCE OUR COMMITMENT TO OUR MISSION.
